

PFAS: How IAEG is tackling the challenge?

The proposed REACH restrictions on PFAS are a concern for the Aerospace and Defence industry due to the range of substances covered and the widespread use of these substances. IAEG is moving into action with different activities taking place to help the industry.

WG5 is forging ahead with assessing the impact of the proposed EU REACH PFAS restriction on IAEG companies and their supply chain. The work group member companies have been surveyed to identify known uses. The next step involves engaging with the supply chain to determine the level of impact and understanding. The aggregated results will be published in a white paper which will be shared with trade associations and standard bodies to support the global industry response to the proposed PFAS Restriction.

WG9 focusses on global communication around PFAS and awareness of PFAS global regulations. WG9 is preparing a fact sheet on PFAS, followed by a webinar that will be open to all IAEG members and their supply chains.
